The Stewards, having received a report from the organiser, summoned (summons No. 01, Doc. No. 4.1), and heard the driver(s) [name(s)] and team manager Mr. Vincent Duchet, have considered the following matter, determine the following:

Fact: The entry to Rally Liepaja was made on 13 June with the FIA Registration System.

The entry fee of 2.900 € was credited to the organiser's bank account only on 28.6.

Offence: Breach of Art. 22.1 of the FIA Regional Rally Sporting Regulations (RRSR)

Breach of Art. 3.12.1 of the Code

Decision: Reprimand

Reason:

Mr. Duchet explain, that it was a very busy month. The driver had a lot of thinks in his mind. Nevertheless, Mr. Lukyanuk paid the entry fee. Mr. Duchet does not understand, why the Stewards consider this matter, because a lot of team paying lat.

The competitor entered the event on 13 June 2021 but paid the entry fee only on 28. June 2021. This was 15 days after the entry was submitted.

According to Art. 22.1 of the FIA Regional Rally Sporting Regulations they must send the due entry fee and the completed entry form to the rally secretariat before the closing date. An Entry may be made by any electronic means of communication provided it is dispatched before the time limit fixed for the closing of Entries and the required Entry fee is lodged concurrently. (Art. 3.12.1 of the Code).

The Stewards conclude that a late payment of entry fees is a breach of the Code and of the FIA RRSR. However, The Stewards are aware that it is a bad habit for entry fees to be received late or not at all by the organisers. A reprimand seems to be adequate, nevertheless, the Stewards in the ERC will from now on pay strict attention to the fact that the money is received on time after the entry has been made.

The decision is based on the FIA International Sporting Code Art. 11.9.1, Art. 11.9.3 f; and Art. 12.4.1.b.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.

According to Art. 12.3.3.b of the Code this decision of the Stewards becomes immediately binding even in the event of an appeal, since it concerns questions of irregularity of Entry by a competitor entering a competition.
